

## Introduction

[Service\\_Exporter.com](#) a "Site" is an electronic commerce platform are mostly employed by online business entities to aid electronic commerce and the usage of these particular business fails to usually entail the range of information that is personal of people today .

[Service\\_Exporter](#) is committed to safeguarding its users' privacy. We request all our users to read the following 'privacy policy' to understand how their personal & business information will be treated, as they make full use of our services to their benefit. This policy is applicable only to the entire network of marketplaces operated by us and not by any other company; and describes precisely how we may possibly collect, employ and reveal details in terms of end users of our network.

## Collection of Information

[Service\\_Exporter](#) collects information from its users when they register to gain access to our services or at other specific instances when they are requested to provide us with their personal & business information. During registration, we ask the users for their name, email address, business information and other personal details. Some or all data collected during a promotion may be shared with the sponsor. However, you can decide not to participate in the promotion if you don't want your data to be shared.

We also gather usage statistics such as pages viewed, number of unique visitors, browser software, screen resolution etc. for analysis that helps us provide you improved user experience and services.

## Use of Personal & Business Information

When you provide any kind of Personal Data to us, that you are presumed to have permitted us to collect and use that Personal information for the following reasons:

**Service\_Exporter** 's primary goal in collecting personal or public information is to provide the user with a customized experience on our network. This includes personalized services, interactive communication and other services.

We record buying and browsing activities of our users including but not limited to their client's contact details and profiles and uses the same to provide value-added services to our users.

Conducting research and statistical analysis that allows you to improve the layout and content of the Marketplace, to improve our services and offerings and for promotional and marketing purposes

## Sharing of Information

As a general rule, **Service\_Exporter** will not disclose or share any of the user's personally identifiable information except when **SE** has the user's permission or under special circumstances, such as when **SE** believes in good faith that the law requires it or as permitted in terms of this policy.

**SE** does not display user email addresses on marketplace to avoid extraction by email extractors.

**Service\_Exporter** may also disclose account information in special cases when **SE** has reasons to believe that disclosing this information is necessary to identify, contact or bring legal action against someone who may be violating **SE** 's Terms of Services or may be causing injury to or interference with (either intentionally or unintentionally) **SE** 's rights or property, other **SE** network website users, or if **SE** deems it necessary to maintain, service, and improve its products and services. Personal information collected may be transferred and shared in the event of a sale.

## Distribution of Information

**Service\_Exporter** may, from time to time, send its users emails regarding its services. **SE** constantly tries and improves the marketplace tools for better efficiency, more relevancy, innovative business matchmaking and better personal preferences. **SE** has many match making tools on the marketplace to be used by

its users for making relevant business contacts with each other. **SE** may allow direct mails using its own scripts (without disclosing the email address) with respect/pertaining to the products and services of third parties that it feels may be of interest to the user or if the user has shown interest in your company for business requirement by way of our paid buyers-sellers contact services. All users shall be able to control the information sharing through their administration panel available at **Service\_Exporter** Only **SE**, its registered members or its agents working under confidentiality agreements will send these direct mailers. ## Updating of Information

A user may edit his/her account information and profile by logging onto our website and/or by sending a request to [info@serviceexporter.com](mailto:info@serviceexporter.com). The requested changes may take up to 30 days to appear online because of verification process and server cache policies.

A user account can be deleted or deactivated, but doing so will result in the user not being able to access any members-only area of the network. Residual information will remain within our archive records.

## Protection of information

As with all information, **SE** do not sell any data in bulk to third party that can be misused for telemarketing or bulk mailing or any other wrong purposes. In addition, **SE** does not sell any user's personal information or business information until and unless it is permitted by the user. Any user statistics that we may provide to prospective advertisers or partners regarding product or service usage on **SE** network is provided in an aggregate form only and does not include any personally identifiable information about any individual user. Users may log in to **Service\_Exporter** to check current status of their contact sharing permissions.

We request our users to sign out of their **SE** account and close their browser window when they have finished their work. This is to ensure that others cannot access their personal or business information and correspondence, if the user shares the computer with someone else or is using a computer in a public place.

**SE** takes necessary steps, within its limits of commercial viability and necessity, to ensure that the user's information is treated securely.
